**GENERAL AGREEMENT:**

The mare owner agrees to breed the designated mare to SB Flashy Zipper (APHA #274,708, PtHA #76892, AQHA # X0636130) during the 2010 breeding season. Breeding season begins February 1, 2010 and ends June 1, 2010. A copy of the mare's registration papers should accompany this contract as well as a non-refundable, non-transferable \$250.00 booking fee, which will reserve the breeding and will be deducted from the total breeding fee. The remainder of the breeding fee, plus collection fee is due prior to the first shipment.

**SHIPPED COOLED SEMEN:**

1. There will be a \$250.00 charge for the first shipment of semen (payable in advance of shipment), any additional shipments will be in the amount of \$175 .00
2. Semen requests must be received no later than 9:00 a.m. (Eastern Standard Time) on regularly scheduled breeding days, which are Monday, Wednesday and Friday. If other arrangements are required, client must contact CRANBERRY RUN FARM immediately – [cranberryrunfarm@aol.com](mailto:cranberryrunfarm@aol.com) or 609-217-1812.
3. SB Paint Horses must be notified by 10:00 a.m. (Eastern Standard Time) to cancel a shipment or the \$250.00 shipping fee will still apply.
4. The mare owner shall assume the risk and expense associated with a lost or delayed shipment and shall hold SB Paint Horses harmless.

**GUARANTEES:**

**Live Foal:**

The stallion owner guarantees a live foal. Live foal is defined as a foal that stands and nurses without assistance. If the mare aborts the foal OR the foal dies within 24 hours of birth the mare owner is entitled to one rebreed. The rebreed is for the same mare to the same stallion and must be used the following year of contract.

**COLOR GUARANTEE FOR APHA BREEDERS:**

LCFG will be for one-half of the usual fee OF \$400.00, (\$200.00). This LCFG applies only to APHA registered mares, and not available to AQHA registered mares. If the resulting foal does not qualify for regular registry, the mare owner shall receive one rebreed, for the year foaled, at half of the advertised breeding fee (\$400.00 /\$200.00), for the same mare to the same stallion. There is no color guarantee for rebreeds or Breeders Futurity purchases.

**PAYMENT:**

Payment in full is due prior to the collection. Payment will include the remainder of semen fee if booking fee is paid in advance or \$400.00 for semen plus \$250.00 for collection (does not includes FedEx shipment). Stallion owner will notify mare owner of tracking number once the semen has been shipped. There will be no container deposit due to the use of disposable containers. If the mare owner requires an Equitainer, failure to return the container in a reasonable time (within 3-5 days of final insemination) will incur a \$200.00 late fee.

A breeder's certificate will be issued upon notification of the birth of the foal, providing all accounts are current.

The mare owner's signature attests to the fact that the owner has read and understands all of the outlined herein and accepts this contract as a legal and binding instrument in the State of New Jersey. This contract cannot be assigned or transferred. Stallion owner will sign and return a copy of this contract to the mare owner within 3 days of receipt.
